FOREWORD

We are pleased to present the Annual Report on Port State Control in the Mediterranean region for year 2018, which published under the auspices of the Port State Control Committee of the Mediterranean MoV.

The 10 members of the memorandum have carried out 5,343 inspections; the number of detentions was 142 in 2018.

The Med MoV Committee meeting received a kind invitation from the Maritime Authority of Georgia to host the 20^{th} Committee meeting. The port town of Batumi hosted the Georgia International Maritime Forum (GIMF 2018) on 12th-13th September 2018 in parallel with The 20^{th} Med MoV Committee meeting on 12th-14th September 2018. The GIMF is dedicated to the 70th anniversary of the International Maritime Organization. This was an important landmark event for the Med MoV.

There are several notable developments in the Med MOU in 2018, the new information system for the Mediterranean Memorandum of Understanding on Port State Control: THETIS-Med presented at the 20th Committee meeting, it will be used by the PSCOs across the Mediterranean to select ships for inspection and report inspections' results. A Concentrated Inspection Campaign (CIC) n "MARPOL Annex-VI" was carried out from 1 September to 30 November 2018. Throughout the year 2018 the Med MoU Secretariat has continued to develop the quality system in order to improve service which has been certified for, ISO 9001:2015.

This annual report highlights the developments and activities of the Med MOU in 2018. Moreover, the report also provides port State control statistics and analysis on the results of inspections carried during 2018.

We would like to thank all the members of the Management Advisory Board (MAB) who continued to serve the Med MoU throughout 2018 and all of the Committee Member States for their support during the year and we would like especially to thank all of the Med MoU Port State Control Officers and their Administrations for their excellent work throughout the year.

OVERVIEW

Introduction:

This Annual Report published under the auspices of the Med MoU Committee on PSC. This annual report is the thirteenth issue and covers port State control activities and developments in the year 2018.

In accordance with the provisions of the Memorandum, the Authorities which have signed and formally accepted the Memorandum or which have been accepted with unanimous consent of the port State control committee would become full members.

Currently, the Memorandum has 10 full members namely: Algeria, Cyprus, Egypt, Israel, Jordan, Lebanon, Malta, Morocco, Tunisia and Turkey.

The Port State Control Committee established for Monitoring and controls the implementation and on-going operation of the Memorandum.

The Committee consists of representatives of the member Authorities and also observers from the maritime Authorities and the inter-governmental organizations which have been granted observer status by the committee, namely: International Maritime Organization (IMO), International Labour Organization (ILO), European Commission (EC), Paris MoU, Black Sea MoU and the US Coast Guard.

The Secretariat of the Memorandum is located in Alexandria, Egypt and its Information Centre in Casablanca, Morocco.

THE COMMITTEE

The Twentieth Committee Meeting was held in Batumi, Georgia from 12 to 14 September 2018. The meeting was attended by the representatives of the member Authorities of Cyprus, Egypt, Malta, Morocco and Turkey, observers from the European Maritime Safety Agency (EMSA). The Maritime Administration of Georgia was presented during the opening session of the meeting.

Important outcomes of this meeting:

- The Committee meeting approved to follow the 2019 CIC on "Emergency Systems" including electrical systems and equipment covered by SOLAS Chapter II-1 jointly prepared by Paris MoU and Tokyo MoU.
- The Committee meeting approved the renewal of the Data Exchange Agreement with Genscape Vesseltracker for a period of three years starting from 1st day of March 2018 till 28th February 2021.
- The Committee meeting discussed the ingoing development of the new system "THETIS-Med" which will be developed by EMSA within the activities of the SAFEMED-IV project and agreed to establish a Steering Committee in order to be able to take decisions in between the Med MoU MAB, Committee meetings and decided to include the Secretariat, CIMED, Cyprus, Malta and Morocco within the Steering Committee.

MANAGEMENT ADVISORY BOARD MEETINGS (MAB)

The Management Advisory Board for the Mediterranean Memorandum of Understanding on Port State Control met two times in year 2018. Cyprus, Egypt, Lebanon and Turkey were MAB members in 2018.

- The Twentieth meeting took place in Limassol, Cyprus from $26^{th} 27^{th}$ June 2018.
- The Twenty-first meeting took place in Batumi Georgia on 12th of September 2018.

MAB Minutes:

Through two meetings following are the outline remarks on the MAB Minutes:

- The MAB requested the Secretariat of the Med MoU on PSC to draft a Policy for the consideration and acceptance of new member States and other Organizations meriting either 'Full' or 'Observer' status to the Med MoU on PSC.
- The MAB meeting requested the Med MoU on PSC Secretariat to coordinate a
 correspondence group to provide the Committee with a proposal on the project of
 "PSCOs development structure scheme" to categorize and promote PSCOs according
 to qualifications and levels of training.
- The MAB meeting agreed to submit that proposal on annual action plan to fund the Education and Training of PSCOs including PSCOs exchange programmes to the Committee.
- The MAB meeting discussed the issue of developing the guidelines on Ballast Water Management Convention, and agreed to submit the proposal provided by the Maritime Authority of Malta, to the Committee.



THE INFORMATION CENTER (CIMED)

The Med MoU Information Center has been established in Morocco, for the purpose of exchanging information on port State inspection, in order to make available to authorities information on inspection of ships on other regional ports to assist them in their selection of foreign flag ships to be inspected and in the exercise of port State control in the region.

Most important achievements of the CIMED:

- Data exchange is always current with (GENSCAPE, EQUASIS, LLI, IMO, HIS, BS MoU).
- From July 2015, the Electronic Platform (MaKCs) hosting DLP and on Rule Check tool is available for all Med MoU PSCO's.
- MEDSIS mobile / Tablet is a public app displaying data from MEDMOU on port state control system, android version is available on Google store, and IOS version is also published.
- A checkbox for ISM related deficiencies in the 'Inspection Form' has been integrated into the MedSIS system.

CONCENTRATED INSPECTION CAMPAIGN (CIC)

- Between the 1st of September 2018 and the 30th of November 2018, ten Med MoU member states carried out a Concentrated Inspection Campaign (CIC) on MARPOL Annex VI.
- A total of 878 inspections were carried out with the CIC questionnaire. The overall CIC detention percentage was 1.8% (15 ships were detained).
- 1,270 ships inspected during the period of CIC and 878 inspections were performed with a CIC questionnaire.
- 28 ships were detained in the CIC. 1 detentions or 4 % of the detentions were CIC topic related. The overall detention rate (Percentage of all detentions per all inspections using CIC questionnaire) was 1.8 %. The CIC topic related detention rate was 0.11%.
- The overall rate of 0.11% for CIC-topic deficiency rate (average number of deficiencies reported per inspection) is a satisfactory result.



CO-OPERATION WITH THE IMO

- The Med MoU has inter-governmental status (IGO) since 2006 in IMO meetings.
- Exchange of Data with IMO; the uploading into GISIS is always current starting from August 2011.
- The Med MoU Secretariat's representative participated in the 5th session of the Sub-Committee on Implementation of IMO Instruments (III 5) which held in London, from 24 to 28 September 2018.

CO-OPERATION WITH THE EUROPEAN COMMISSION

Following the achievements of the previous EuroMed Cooperation on Maritime Safety and Prevention of Pollution from Ships (SAFEMED) projects, the European Commission launched the fourth SAFEMED project (SAFEMED IV). The European Maritime Safety Agency (EMSA) will be the implementing body of the project, started the development of the new information system for inspection data (THETIS-Med).

- On the 11 December 2018, EMSA organized a technical meeting on the development of THETIS-Med at the Merchant Marine Directorate of the Kingdom of Morocco for further technical discussion on the development of the THETIS-Med between EMSA, CIMED and the Med MoU Secretariat and in the presence of the Moroccan Maritime Merchant Director.
- From 10-11 October 2018, EMSA organized the Second Steering Committee Meeting
 on the SAFEMED IV project in Aqaba, Jordan and the Med MoU on PSC Secretariat
 represented and presented the recent activities and developments in
 the Mediterranean Region.

CO-OPERATION WITH PARIS MOU

- The Med MoU has established and maintained effective and close cooperation with the Paris MoU, both at administrative and technical levels.
- Chairman of Med MoU on PSC Capt. Mark A. Chapelle represented the Med MoU at the 51th Paris MoU Committee meeting in Cascais, Portugal, on 07-11 May 2018.
- Paris MoU organized the specialized training on the Inspection of Bulk Carriers for Port State Control Officers in The Hague, Netherlands from 20 to 23 March 2018. The Maritime Authority of Israel representative participated in the course on behalf of the Med MoU.

CO-OPERATION WITH BLACK SEA MOU

The Med MoU has a special cooperation with the Black Sea MoU in the area of exchanging PSCOs to gain experience and harmonization on the job training between both MoUs.

The Med MOU was represented by the Republic of Turkey at the 19th Black Sea MoU Committee meeting in 2018 in Odessa Ukraine from 17 to 19 April.

CO-OPERATION WITH TOKYO MOU

The Eighth general training course (GTC8) for PSCOs organized by the Tokyo MoU, in cooperation with IMO was held in Japan, from 20 August to 14 September 2018; the Maritime Authority of Jordan representative participated in the course on behalf of the Med MoU.

CO-OPERATION WITH INDIAN OCEAN MOU

The Expert Mission Training on Port State Control (PSC), hosted by the Indian Ocean MoU in cooperation with IMO and the Tokyo MoU, was held in Mombasa, Kenya from 8 to 19 October 2018. The Maritime Authority of Egypt representative participated in the training e on behalf of the Med MoU.



ANNUAL STATISTICAL REPORT 2018

In the following annual statistics the figures of 2018 are listed, the figures show an increase in the number of inspections and decrease in the number of detentions.

INSPECTIONS

With a total number of 5,343 inspections performed in 2018, the inspection figures showed an increase of 143 inspections (2.75 %) compared with the figures of 2017.

The greatest contribution for inspections was from Turkey with 1,438 inspections then from Egypt with 1,100 inspections.

The greatest percentage of inspections was in the "General cargo/multipurpose ship" which was 1760 inspections (33% of all inspections).

DETENTIONS

The detention figures showed a decrease in the number of detentions in 2018 compared with 2017. The average detention rate in 2018 is 2.66%, which is lower than 2012, which showed a detention rate of 7.57%.

The greatest percentage of detentions was on "General cargo/multipurpose ship" which is 93 detentions (65% of total number of detentions).

DEFICIENCIES

Number of deficiencies (11,304)

In 2017, the number of deficiencies recorded was 12,786 deficiencies; in 2018, this number decreased by (11.6%) compared with 2017. The ratio of deficiencies per inspections decreased from 2.45 in 2017 to 2.11 in 2018.

The greatest percentage of deficiencies recorded was on "Certificate & Documentation" with 18.6% of total number of deficiencies (2,103 deficiencies), 1,699 deficiencies recorded for the "Safety of Navigation" and 1,155 deficiencies for the "Fire Safety".

Number of inspected ships with deficiencies (2,484)

The greatest number of ships with deficiencies was in "General cargo/multipurpose ship" which recorded 1,227 ships (49% of total number of inspected ships with deficiencies).












Number of detentions




Detentions in % of inspections






Inspections for year 2018






Number of Inspections, Detentions and Inspections with deficiencies per member state






Number and % of inspection, deficiencies and detention per ship's type






Number and % of nature of deficiencies
